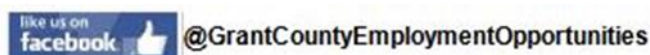
1. All appointees must successfully complete 120 hours of certification and 24 hours of annual inservice training as required by the Law Enforcement Standards Board.

### **NATURE OF WORK**

These positions perform a variety of duties connected with the operation of the County Jail.

### **MINIMUM QUALIFICATIONS**

#### Education:

2. Basic computer concepts

4. State of Wisconsin Jailer Certification preferred

#### Knowledge, Skills and Abilities:

1. Skill in reading and comprehending written materials
2. Oral and written communication skills
3. Ability to enter data in computer system
4. Ability to gain the respect and control the behavior of inmates
5. Ability to take prompt and decisive action in emergency situations
6. Ability to restrain combative inmates
7. Skill in self-defense
8. Ability to maintain a positive attitude and emotional control
9. Ability to follow work procedures and rules
10. Ability to work in a confined area for an extended period of time
11. Ability to spell and write legibly
12. Ability to work effectively and harmoniously with others

### **ESSENTIAL FUNCTIONS**

Under general direction

1. Maintain care and custody of male or female prisoners
2. Book, search, strip and bodily examine inmates and check their clothing and possessions
3. Maintain proper security including patrol duty and periodic counts of inmates
4. Maintain proper order and decorum among prisoners
5. Physically restrain combative inmates
6. See that inmates follow proper procedures as to personal hygiene

7. Administer first aid and assist in dispensing medications Ensure that the quarters of inmates and the areas for which they are responsible are kept in a safe and sanitary condition
8. Issue supplies to inmates
9. Assist with the dispensing of food
10. Check incoming and outgoing mail
11. Supervise work details of inmates in their quarters or other areas
12. Report infractions of rules and unusual occurrences
13. Prepare inmates for court and for release
14. Conduct transport of inmates
15. Supervise inmate visitations
16. Verify employment and maintain employment and financial records of Huber prisoners
17. Keep records and prepare reports
18. Perform such other duties as may be assigned
19. AVAILABILITY TO WORK ANY SHIFT, WEEKENDS AND HOLIDAYS REQUIRED

### **SUPERVISION RECEIVED**

General and specific assignments are received and work is performed according to prescribed methods and procedures.

### **SUPERVISION EXERCISED**

May supervise part-time and/or limited term positions

### **ENVIRONMENTAL FACTORS**

Exposure to violence, noise, and uncomfortable conditions as may be found in a jail environment.

### **PHYSICAL DEMANDS**

Requires hand – eye – coordination, may sit or stand for long periods of time; lift or carry up to 50lbs.; stoop, kneel, crouch, or crawl frequently; bend, squat, stretch, and twist frequently; Restrain combative inmates as necessary. Dexterity in moving, picking up objects and operating office equipment is required.
