### **COST SHARING POLICY**

(Revised 12/01/2022)

- The CSZD will approve all project applications for County and DATCP cost sharing prior to construction.
  - Wells that need to be abandoned immediately due to emergency situation must contact the office prior to abandonment and provide documentation stating case for emergency.
  - Only wells in rural areas are eligible, those located in a municipality or sanitary district are ineligible for cost sharing.
- All practices, with the exception of well decommissioning and management practices must be considered for DATCP cost sharing first if available.
- All practices may be piggybacked with County cost sharing, to bring the total cost share percentage to 75%, depending on limits and availability of county funds.
- All cost-sharing recipients must pay bills in full and offer proof of payment in the form of paid receipts, cancelled checks, or bills marked "paid," before county or DATCP costsharing payment is made.
- Any applicant with an outstanding Conservation, Sanitation and Zoning Department
  Ordinance violation will not be eligible to receive County Cost Sharing, unless said cost
  sharing is used to bring them into compliance
