Motion by Vince Loeffelholz, seconded by Lester Jantzen to keep the same menu throughout the fair with the addition of hamburger and cheeseburgers on Wednesday night. Motion carried.

Motion by Pat Schroeder, seconded by Lester Jantzen to take out requirement for EMT ambulance service at possible future go-kart events as long as the promoter has written confirmation that the promoter's liability insurance will cover the event without the presence of EMT emergency ambulance service and with approval of county legal counsel. Motion carried with one no vote.

Motion by Vince Loeffelholz, seconded by Pat Schroeder to go with Plan 1 as submitted by Mike Holzer for displaying dioramas in the Eckstein Exhibit Hall during the 2011 Fair. Motion carried.

Motion by Pat Schroeder, seconded by Bob Keeney to hire Reynolds Electric to install electricity to the Rabbit & Poultry Building. Motion failed.
