September 20, 2011

The Grant County Board of Supervisors met on Tuesday, September 20, 2011 at 6:00 p.m. in Room 264 of the Administration Building, Second Floor in Lancaster, WI pursuant to the adjournment of the August 30, 2011 meeting.

Chair John Patcle called the meeting to order and the Pledge of Allegiance was recited.

The Clerk took the roll call resulting in 13 present, 4 absent (3 excused and 1 absent). John Beinborn arrived late after the meeting was called to order.

Larry Wolf, seconded by Stephen Adrian, made a motion to approve the agenda. Motion carried.

Lester Jantzen made a motion, seconded by Vern Lewison, (Vern Lewison was not in attendance at the July 19, 2011 meeting so he rescinded his second), and Robert Scallon seconded the motion to approve the minutes of July 19, 2011. Motion carried.

Dwight Nelson, seconded by Don Splinter, made a motion to approve the minutes of August 30, 2011. Motion carried.

Employee Recognition: None

<u>Communications</u>: John Patcle noted that this weekend the WCA Convention will start in Wisconsin Dells at the Kalahari Resort.

John Patcle also informed the board that Grant Loy had been hospitalized; this was the reason he was not in attendance at the meeting.

Appointments: None

<u>Grants</u>: Jack Johnson, Deputy Chief Sheriff, requested approval for a \$1,000.00 grant from Walmart Corporation, no match to county to purchase first aid supplies. He also requested approval for a \$1,000.00 grant from Sam's Club for canine supplies, no match to the county. Robert Scallon, seconded by Margaret Ruf, made a motion to approve the two grants for the Sheriff's Department. Motion carried.

<u>Radio Project Match Funding Request</u>: Jack Johnson, Deputy Chief Sheriff was present to request the sum of \$38,647.00 to meet the County's matching fund payment for a Radio Project that was implemented in 2010. Emergency Management obtained a grant for \$225,000 for radio updates and new repeaters. The grant was received in 2010 to satisfy the State mandatory installation of narrow band in the Sheriff's Department which had to be completed by 2013. The match was to be paid out of the Sheriff's Communication fund if the money was available. Jack stated that there was not enough money in the Communication Fund to pay the match off, therefore; the Sheriff's Department was requested the funds to be paid out of the General Fund. The request was brought before the Executive Committee and was recommended for passage by the Grant County Board of Supervisors. Robert Scallon, seconded by Lester Jantzen, made a motion to approve the amount of \$38,647.00 is transferred out of the General fund to satisfy the Counties matching payment for the radio update in the Sheriff's Department. Motion carried.

<u>Belmont Trail</u>: Angie Wright, Southwest Badger Resource Conservation and Development was present to answer any further questions the Board may have for passage of the Memorandum of Understanding and the Easement agreement with DNR for the Pecatonica Trail. This item had been introduced to the Board at the last County Board Meeting in August and was held over to the September meeting to give the Corporation Counsel time to review the verbiage of this agreement. There was a question on how much the recording fees would be to Grant County concerning the easement request. Todd Infield, Corporation Counsel stated that the fee probably would be about \$30.00. Mark Stead, seconded by Margaret Ruf, made a motion to accept the terms of the Memorandum of Agreement and Easement Agreement between, Lafayette County, The City of Platteville and Grant County and the Wisconsin Department of Natural Resources concerning the portion of the Pecatonica Trail. Motion carried with no nay votes.

<u>Ordinance relating to the carrying of firearms in Public Buildings</u>: This issue was held over to address at the October County Board of Supervisor Meeting so the Ordinance could first be reviewed by the Law Enforcement Committee.

<u>Grievance Procedure</u>: Joyce Roling, Personnel Director gave the Board a short review of the Grievance Policy Procedure for the County. This new Grievance Policy will need to be approved by the County Board of Supervisors; Joyce wanted to answer any question that there may be on this new Policy. Joyce also stressed that there is a timeline that has to be followed by the Counties to pass these new resolution with in their structure and that the Transition Team has worked a long time on these policies so they can be implemented since Governor Walker's Bill was passed. The Resolutions can be passed now; but they can be amended in the future to allow for any changed that would occur mandating to clarify the purpose or wording in these proposed policies. Another concern of the Board was that these policies were being reviewed by all the Grant County Employees and not just Department Heads. Joyce stated that all the Policies have been sent to the Department Heads with instructions to allow their employees the opportunity to review them. Joyce will send out another email to all Department Heads to insure that the Department Heads are following through with this request. Margaret Ruf, seconded by Larry Wolf, made a motion to approve the Grievance Procedure for Grant County with the following amendment. That the Policy reflect that, if an Impartial Grievance Counselor is needed in a grievance procedure; the cost incurred will be paid half by the County and half by the person submitting the grievance. And also, on page 3 under subtitle (2) Decision of Personnel Director, the wording "the Personnel Director may deliver a written response to the Grievant" be changed to say "the Personnel Director will deliver a written response to the Grievant". Motion carried.

<u>Pay Period and Pay Day Policy Revision</u>: Joyce Roling, Personnel Director explained the Pay Period and Pay Day Policy to the Board. The Finance Department would like to make Direct Deposit of the employee's paychecks mandatory as of January 1, 2012. Currently, Nancy Scott, Finance Directed stated that the Direct Deposit in the County is at about 77% participation. Lester Jantzen seconded by John Beinborn made a motion to approve this policy. Motion carried with three nay votes, Mark Stead, Robert Scallon and Stephen Adrian.

<u>Overtime and Compensatory Time Policy</u>: After a short discussion, Robert Scallon, seconded by Don Splinter, made a motion to approve the Overtime and Compensatory Policy. Motion carried.

<u>Public Hearing</u>: Mark Stead, seconded by Don Splinter, made a motion to go into the Public Hearing to address any questions on the proposed Final Supervisory District Plan for Grant Count. Motion carried.

<u>Reconvene to County Board</u>: Vern Lewison, seconded by John Beinborn, made a motion to reconvene back to the County Board meeting. Motion carried.

ORDINANCE # 61

ORDINANCE TO ADOPT COUNTY SUPERVISORY DISTRICT PLAN FOR GRANT COUNTY 2011

The Grant County Board of Supervisors do ordain as follows:

The following are the Supervisory Districts for Grant County as adopted by the Board of Supervisors on this 20th day of September, 2011.

DISTRICT 1

<u>Village of Muscoda, Ward 1</u>, consisting of all land lying north of Beech Street from Sportsman Drive to County line within the Village of Muscoda corporate limits; <u>Village of Muscoda, Ward 2</u>, consisting of all land lying south of Beech Street that is within the Village of Muscoda corporate limits; <u>Town of</u> <u>Muscoda</u>; <u>Town of Watterstown, Ward 1</u>, consisting of all lands north of Forest Road west to County Highway T, westerly to the intersection with County Highway M, westerly on County Highway M to the west town line; <u>Village of Blue River</u>; <u>Town of Boscobel</u>, <u>Ward 2</u>, consisting of all land east of Highway 61 and north of Old C, to Doc Mac Drive, to Oakes Rd., to County Highway M, to Cedar St.

DISTRICT 2
