Public hearing was convened (Ch. 59.69-5e) to hear the request of Joseph & Mary Cogan to rezone 23.79+-ac. from Exclusive Agriculture EAZ to Commercial C-2. This land is located in SW ¼ of SE ¼ Section 28 T1N R2W in Jamestown Township.
