Motion by Bob Keeney, seconded by Pat Schroeder to approve the following prices for the 2012 Grant County Fair: leave daily gate admissions at \$5.00; leave exhibitor tickets at \$5.00 for open class, \$2.00 for senior citizen and \$2.00 for junior class; raise season admission ticket from \$7.00 to \$10.00; and leave the all event ticket at \$20 for pre-advance and \$25 for advance. Motion carried.

Motion by Bob Keeney, seconded by Lester Jantzen to leave grandstand admission fees the same. Motion carried.

Motion by Vince Loeffelholz, seconded by Grant Loy, to pass on to the full county board the livestock claims from Lancaster Veterinary Clinic in the amount of \$549.10. Motion carried.

Motion by Vince Loeffelholz, seconded by Grant Loy to adjourn until February 17, 2012. The next monthly meeting will be held February 20, 2012. Motion carried.
