### April 17, 2012

The Grant County Board of Supervisors met on Tuesday, April 17, 2012 at 9:05 a.m. in Room 264 of the Administration Building, Second Floor in Lancaster, WI pursuant to the adjournment of the March 20, 2012 meeting.

Public Hearing: Motion made by Lester Jantzen, seconded by Vincent Loeffelholz to convene to public hearing. Ron Brisbois, Economic Development Director made the presentation. The purpose of the hearing was to provide the citizens of Grant County an explanation of the Community Development Block Grant for Economic Development (CDBG-ED) program, program goals and the application process along with a discussion of the economic development needs of Grant County and to provide an update on the EMS-USA project in Cuba City. The County also wanted to receive citizen input on the project and the \$300,000 in CDBG-ED funds that were loaned to EMS-USA Insulated Doors. The funds were utilized by EMS-USA to expand their manufacturing operations and create jobs. Activities will benefit low and moderate income individuals through the creation and/or retention of jobs. The citizens of Grant County were urged to attend and participate in the meeting. The Public Hearing Notice was posted in the County designated paper, The Herald Independent, for two postings prior to the County Board of Supervisor Meeting. Questions fielded from county board. Ivan Farness motioned to return to open session, seconded by Don Splinter. Motion carried.

<u>Grants</u>: Jeff Kindrai requested approval to apply for grant money from the Lancaster Community Fund to support the "Plunge" event in 2012. The Plunge is a day long event to help curb underage drinking involving many community partners. Funding period will be July 1, 2012 to July 13, 2013 for \$2,000, no match by County. Motion by Robert Scallon, seconded by Ivan Farness. Motion carried.

Keith Govier requesting approval to apply for grant money with the Wisconsin Department of Transportation for multi-county traffic enforcement on the Highway 151 corridor. The grant would be for \$5400.00 – no match to the county. Lester Jantzen, seconded by Mark Stead made a motion to approve the application for this grant for Law Enforcement. Motion carried.
