The Grant County Conservation, Sanitation & Zoning Committee meeting was called to order on January 9, 2015 at 9:00 a.m. by Mark Stead, the Conservation, Sanitation, and Zoning Committee Chairman in the Grant County Conference Room #266, 111 S. Jefferson St., Lancaster.

Sanitary Permit Summary:

Sanitary permits issued to date: 28 reconnects, 2 privys, 2 revised permits for transfer. There were 109 replacement permits for the year; along with 59 new permits totaling 168 total permits issued in 2014. Totals were about the same as last years' totals. Roger Guthrie made a motion to accept the Sanitary Permit Summary, seconded by Lester Jantzen. Motion carried.

Wisconsin Fund Report:

Lester Jantzen made a motion to accept the Wisconsin Fund Report, seconded by Myron Tranel. Motion carried.

County Cost Sharing Requests

Lynda presented 1 county cost share cancellation request for Todd Fischer, Marion Twp., on a manure storage project for \$3,500.00. He has made changes and no longer needs the cost share. Motion by Pat Schroeder, seconded by Roger Guthrie to approve Todd's cancellation request. Motion carried

Lynda presented final approval request for county cost sharing of \$165.00 on a well decommissioning for Dustin Kopp, South Lancaster Twp. Motion by Dwight Nelson, seconded by Lester Jantzen to approve payment. Roll Call: 7 Yes, 0 No, 0 Absent. Motion carried.

Lynda presented final approval request for county cost sharing of \$2,008.94 on a storage abandonment for Doris Vesperman, South Lancaster Twp. Motion by Myron Tranel, seconded by Dale Hood to approve payment. Roll Call: 7 Yes, 0 No, 0 Absent. Motion carried.

Lynda presented tentative approval requests for county cost sharing on 3 well decommissionings for Mike Meier, West Beetown, Twp. \$500.00; Neal Donner, Muscoda Twp. \$500.00; and for Gerard Abing, Platteville Twp. \$149.50. Motion by Dale Hood, seconded by Pat Schroeder to approve the 3 well decommissioning requests. Motion carried.

SWRM Cost Sharing Requests

Lynda presented final approval request for 2014 DATCP cost sharing of \$3,387.15 on a grade stabilization structure project for Bruce Wagner, Paris Twp. Motion by Lester Jantzen, seconded by Myron Tranel to approve payment. Roll Call: 7 Yes, 0 No, 0 Absent. Motion carried.

The DATCP cost sharing of \$63,095.09 has been allocated to practices that the committee had extended at the December meeting. The \$62,500 was the 2015 DATCP cost sharing amount allocated to Grant County. A great improvement by the state this year, the cost sharing money was allocated to the counties much earlier this year.

Approval to Fill Vacant Position Created by Retirement of Administrative 1 Position

Myron Tranel moves to restructure the Conservation, Sanitation, and Zoning Department staff positions by eliminating the Administrative Assistant 1 position, adding an Office Assistant II position and reorganize the Administrative Assistant II position to a Conservation, Sanitation, and Zoning Department Programs Assistant at a step 2 rate, seconded by Lester Jantzen. Motion carried.

Review Labor and Machinery Hour / Rates

Lynda handed out the County Cost Sharing Policy. Last time this was revised was 02/03/2011. Lynda will send a blank cost sharing priorities sheet to the committee so they can rank the practices in the High, Medium, and Low Categories. Will go over the committee's results at the February committee meeting to rank the practices.

Approval of WLWCA Dues

WLWCA has sent out their 2015 Annual Dues Invoice. The current request is for \$1,426.06, and this is what we have in our budget. Motion by Pat Schroeder, seconded by Myron Tranel to approve paying the 2015 annual dues of \$1,426.06. Motion carried.

Approval of the RC&D Dues

Earlier in the year RC&D gave a presentation to the committee of what they do for Grant County, and had made the request to increase our dues from \$200.00 to \$2,500.00. No decisions were made at that time, to pay the increased amount. RC&D has now invoiced us for the 2015 Annual Membership Dues in the amount of \$2,500.00. Motion by Myron Tranel to approve the RC&D dues amount that is approved in the budget, (\$200) seconded by Mark Stead. Motion carried.

Discussion on Changing Our Monthly Meeting Day Due to Dale Hood Serving on the WI Land & Water Board Dale Hood explained that the WI Land & Water Board meets on the first Tuesday every other month, starting in February. Dale is on the WI Land & Water Board through the WI Land & Water Association. They meet in Madison for their meetings. Motion by Pat Schroeder, seconded by Myron Tranel to leave the CSZC meetings set for the 1st Tuesday of the month. Motion carried.

Approval to Attend WLWCA Annual Conference

The Annual WLWCA Conference will be held March 9-11, 2015, in Appleton. If committee members are interested in attending they need to complete the registration form. Lynda is asking for approval to send 4 staff members. Committee members interested in attending are: Mark, Dwight, Lester, and Dale. Motion by Myron Tranel, seconded by Lester to approve the 4 staff members and 4 committee members to attend the WLWCA Conference. Motion carried.

CSZD Administrator Report

Lynda reported that they have just completed the Nutrient Management Farmer Education Training Class. She had 11 people signed up for the class, 10 people attended and completed the class, and 1 will finish the class at a later date. It is a very good service that we provide to our farmers who are interested in writing their own Nutrient Management Plans. It is a very interesting class; Lisa, Annette, Eric, and Kevin assisted this year.

Lynda reported that the 2002 Ford F150 needed some more repair. It needed a thermostat and the 2nd ignition coil went out. Once 1 ignition coil goes, they will all eventually need to be replaced (8) total. Cost is approximately \$300.00 a coil.

Kevin gave a report on the Deer Management Committee with DNR. When Governor Walker was elected he instructed the DNR to set up a Deer Management Advisory Committee which is made up of 7 different stakeholders; tourism, highway, farmers, forester, agriculture, DNR biologist, and wildlife groups. Their recommendation to the DNR was to keep the deer herd the same. Their next meeting is in February.

Ice Cream Social for Janet Graney's retirement farewell is on January 22, from 1-3 in our office.

FPP Report: Kevin Lange

Kevin reported that if you are spot checked in 2013 for FPP and if you need any work done to get into compliance, you are given a year to obtain compliance. Most of the issues are NMP's. NRCS Report: Lisa Zamzow

- ❖ Lisa reported that EQIP has 120 practices, for about \$360,000
- NRCS has 43 CRP contracts for \$145,000. Total for 10 year payment for CRP is \$2.2 million
- ❖ Conservation Stewardship Program (CSP) has 30 contracts in fiscal year 2014 for the life of the stewardship program was \$1.1 million. \$217,000, and for the life of the stewardship program is \$1.1 million.
- CRP rental rates have increased. The mid-management practices are down to just mowing or burning.
- ❖ There is around 150 HEL determinations and approximately 30 wetland determinations that they received in FY 2014.
- Lisa reported on Agribility: It is an organization that helps Wisconsin farmers with disabilities that wish to continue to farm. This is through UW Extension and Easter Seals.
