in writing from the village and the state will look at this. There is a speed trailer available that could be used in this area.

ATV/UTV Requests: There are five requests from the Ridge Runners of Grant County. After much discussion it was motioned by Dave and seconded by Brian to table the requests until the next meeting in May. This will give the Highway Committee time to discuss the routes. Motion carried.
