<u>Grants</u>: Jeff Kindrai, Health Department Director asked for approval to apply for the Heat Stress Reduction Project (Taking action with Data: Use of the County Health Profiles to improve Environmental Health in a Community) grant. The purpose of this grant is to reduce the rate of Emergency Room visits related to heat stress in Grant County. The source of the Grant is WI-Environmental Public Health Tracking Program (WI-DHS). The amount is for \$10,500.00, funding period of 11-01-15 to 07-2-16. No County match is required; only in-kind contributions for time and effort from partners is anticipated to be in excess of \$5,000.

## RESOLUTION NO. 51-14 COUNTY CONSTRUCTION AND MAINTENANCE DURING THE CALENDAR YEAR 2016

SECTION I. The County Board of Supervisors of Grant County, Wisconsin regularly assembled, does hereby ordain that such funds as may be made available to the County for highway work in the year 2016 under the provisions of Section 86.30 of the Statutes, and the additional sums herein appropriated, shall be expended as hereinafter set forth:

SECTION II. COUNTY TRUNK HIGHWAY ALLOTMENT. WHEREAS, the State Highway Commission has notified the County Clerk that a sum of money estimated to be One Million Two Hundred Eighty-Five Thousand, Three Hundred Seventy-Three Dollars and 00/100 (\$1,285,373.00) will become available at the end of the fiscal year under the provisions of Section 86.30 of the Statutes, for the County Trunk Highway System in the County, but the actual amount will not be known until the close of the fiscal year ending December 31, 2015.

BE IT RESOLVED that the County Highway Committee is authorized and directed to expend the said sum to the extent required to match and supplement Federal Aid for construction, right of way, and other cost on any Federal projects located on the County Trunk Highway System of said County, which are not recovered from Federal Funds, and to expend any balance for construction, repairing, and maintaining such County Trunk Highway System and Bridges thereon, including snow and ice removal and control, as directed in Section 86.30 of the Statutes, and to reimburse the general fund for any expenditures that may be made therefore pursuant to Section 86.30 of the Statutes. The distribution to such purpose to estimated, but not specifically directed, to be as follows:

SECTION III. WHEREAS, it appears that certain highway improvements in the County are necessary and warranted,

BE IT RESOLVED that the County Board does hereby appropriate the following sums for the purpose hereinafter set forth:

(1) The Sum of Two Hundred Seven Thousand, Nine Hundred Sixty-Three Dollars and 00/100

(\$207,963.00) for Federal Aid Secondary Projects.

(2) For the Maintenance of the County Trunk Highway System the sum of One Million, Five Hundred Fifty-Five Thousand, Three Hundred Eighty-Nine Dollars and 00/100 (\$1,555,389.00).

(3) For emergency road or bridge repairs or construction, the necessity for which is determined by the County Highway Committee for which other funds are not available, the sum of Two Hundred Fourteen Thousand, Two Hundred Ninety Dollars and 00/100 (\$214,290.00).

(4) For the purchase of machinery the sum of Five Hundred Sixty-Seven Thousand, Nine Hundred Fifty-Six Dollars and 00/100 (\$567,956.00).

(5) For the purchase, maintenance and repair of machinery the sum received from Machinery Rental.

(6) For the purchase of County Gravel Pits and Stone Quarries the sum received from Quarry Fees.

(7) For administration, including salaries, per diem, incidental labor office and travel expense of the County Highway Committee, the County Highway Commissioner, his bookkeepers and assistant not paid from construction or maintenance funds, the sum of One Hundred Ninety-Four Thousand Four Hundred Three Dollars and 00/100 (\$194,403.00).

(8) For bituminous surfacing on County Trunk Highways the sum of One Million, Nine Hundred Four Thousand, Three Hundred Thirteen Dollars and 00/100 (\$1,904,313.00).

(9) For snow and ice control on County Trunk Highways the sum of Nine Hundred Fifty-Two Thousand, Four Hundred Twenty-Six Dollars and 00/100 (\$952,426.00).

TOTAL AUTHORIZED IN THIS SECTION: \$5,596,740.00

SECTION IV. WHEREAS, appropriations are made herein, in addition to the amounts to be received from the State and available for work in the County under Section 86.30 of the Statutes.

BE IT RESOLVED that the County Board does hereby levy a tax on all of the property in the County to meet such appropriations as follows:

(1) For the various purposes as set forth in Section III here of the sum of Four Million, Three Hundred Eleven Thousand, Three Hundred Sixty-Seven Dollars and 00/100 (\$4,311,367.00).

WARNING: It is directed that provision for this levy shall be made in the County Budget, but that this levy shall not be duplicated.

SECTION V. WHEREAS, the various highway activities for which provisions are made in the resolution are continuous from year to year, and the exact cost of any work cannot be known at the time of making the appropriations, therefore;

BE IT RESOLVED that this Board does hereby direct that any balance remaining in any appropriation for specific highway improvement after the same shall have been completed may be used by the County Highway Committee to make up any deficit that may occur in any other improvement, which is part of the same item in the County Budget, for which provisions are herein made, and any balances remaining at the end of the year in any highway fund shall remain and be available for the same purpose in the ensuing year.

SECTION VI. WHEREAS, the exact amount of the funds that will become available from the State for highway purposes in the County under Section 86.30 of the Statutes will not be known until on or after July 1, 2016.

BE IT RESOLVED that the County Treasurer is hereby authorized and directed to make payments for the purposes for which such funds are to be used, as herein before authorized, from any funds in the County Treasury that are not required for the purposes for which appropriated prior to August 1, 2016, and to reimburse such funds in the County Treasury from the sum received under Section 86.30 of the Statutes.

SECTION VII. WHEREAS, the County Highway Committee and the County Highway Commissioner are charged with the duty and responsibility of carrying out the construction and maintenance of the highways for which provision is made, and other related supervisory and administrative duties.

BE IT RESOLVED, that the County Highway Commissioner shall have the authority to employ, discharge, suspend or reinstate such personnel as he deems necessary for such purposes, provided, however, that the County Highway Committee may by action recorded in its minutes determine the number of persons to be hired and may also at any time by action so recorded order the County Highway Commissioner to employ, discharge, suspend, or reinstate any such person. The term "personnel" or "person" shall include all patrolmen, laborers, foremen, bookkeepers or other employees necessary to carry on such activities.

<u>Grant County Humane Society Request</u>: Ben Wood, Corporation Counsel started the discussion. The Humane Society would like to be designated as the Grant County Pound. Lancaster Vet Clinic has taken in stray dogs since 1990 for the County; no formal action was taken to designate them as the official County Pound. Other City Vet Clinic's in Grant County receive stray dogs; Lancaster Vet is the only clinic that is paid for their services to these dogs. Ben and Robert Keeney have reached out to other counties how they handle stray dogs in their counties; Linda Gebhard, County Clerk reached out to the County Clerks for their procedures. Dee Rowe, Attorney and Cari Schaffer, Veterinarian and President of the Humane Society were present to explain to the Board what they felt their goal would be for the Humane Society and to answer questions.

A motion was made by John Patcle, seconded by John Beinborn to have Ben Wood, Corporation Counsel prepare a proposal for a service contract; effective on January 1, 2016 entered into between the Humane Society and Grant County to help protect both entities including reporting of activities over the course of the year. The proposed service contract will be presented to the Grant County Board of Supervisors at the December 2015 meeting for negotiation. Vote was taken, Dan Timmerman voted no, all others voted yes. Therefore motion carried.

<u>Update/Concerns on Courthouse Renovation Project</u>: Robert Keeney, Chair stated the final walk through was October 26; there were 7 items still needing attention. On November 2, 2015 Bulley and Andrews was on site to fix those issues; pictures were sent to Insite. Insite has not received all the final close out materials at this time, the final invoice has not been sent from BEMA. With retainage, the close out cost should be \$264, 307.00.

<u>Update on Master Plan</u>: On October 19 the Administrative Committee met with Kurt Berner, The Samuels Group. Option A has been struck from the options, locating the new Law Enforcement/Social Service/ADRC/parking ramp on a downtown Lancaster campus. Option C was refined, possibly using the Lippert Building location for an option. Nancy Scott contacted BAIRD for some financing options to submit to The Samuels Group. Third floor was discussed; parking still is the problem. The building that housed Weber Jewelry Store and Murray's Electric are being renovated so that space will no longer be available. November 30<sup>th</sup> the Administrative Committee will be meeting again, Robert invited all Board members to attend.

Dave Bainbridge was given the opportunity to speak and submit his proposal to the Board Members for a 20,000 square foot building to house Social Services and Unified at 250 Alona Lane. Space would provide ample parking and a garage. This would be based on a lease agreement for a period of 10 - 20 years.

<u>Committee Structure</u>: Information on different committee structures was included in the packet. Other counties are looking into downsizing their committee structures. A question was asked if this had to be set before the election of the Board Members in April of 2016. Ben Wood, Corporation Counsel stated he felt that should probably be done before that time, but not by the end of 2015.

Carol Beals stated that she felt the Executive Committee would have a lot of duties; that may not be acceptable.

Robert Keeney asked that the Board Members keep thinking about this issue, more discussion will be needed.

Extension/Fair, John Patcle—2016 Fair Plans are underway.

**Conservation, Sanitation, and Zoning--Mark Stead**—Received notice from DATCP approved the 2016 \$164,540.00 allocation. Approved the wildlife damage abatement claims program budget for 2016, set a five year contract plan of administration for that program and set the commodity prices for that program. At the last County Board Meeting Hellmuth Krause had addressed the Board regarding a longstanding property dispute concerning easements through pasture land he owns that is used by a neighbor who built a cabin on a parcel. Mark asked that the following letter sent to Mr. Krause from Conservation, Sanitation and Zoning addressing the issue be added to the minutes:

Dear Mr. Krause,

After the Grant County Board meeting on October 6<sup>th</sup>, 2015, I was directed to look into your concern with the implementation on the Grant County Ordinance, and more specifically, the issuance of Zoning Permit #1561, on 9/24/1999.

After conferring with Grant County Corporation Counsel, Ben Wood, we have found the following.

- 1. According to Section 3.27 of the 1995 Grant County Comprehensive Zoning Ordinance, "Zoning violations are reported to the district attorney who, if they find there is in fact a violation of the zoning ordinance, initiates action in a court of law for final determination."
- According to Section 3.27 (4a) of the 1995 Grant County Comprehensive Zoning Ordinance, "Any Zoning Permit issues in conflict with the provisions of this Ordinance shall be null and void (12) twelve months after the date of issuance."

According to a letter from you dated 7/12/2011, you did contact the District Attorney, and they in fact confirmed that the statute of limitations has passed on this issue, which would have been one year after issuance of the permit (9/24/2000).

We feel that all avenues of appeal have expired and that this issue is closed.

Law Enforcement/Emergency Management, Patrick Schroeder — There was a lengthy discussion regarding Unified Counseling Services being open on Veterans Day and closed the day after Thanksgiving; other employees would like to benefit from that also. With Mark Stead's explanation of this issue, Pat stated that should clear up the situation for other departments. Other issues discussed were regarding the Humane Society and what should be done.

**Railroad, Robert Scallon**—All going well, adding ties between Prairie du Chien and Middleton, bridge is being re-done at Spring Green for \$10 million.

**Hidden Valley, Robert Scallon**—doing well, Crawford County will be the feature in 2016, magazines are still available.

**ContinuUs, Gary Ranum**—Budget was passed for 2016; a lot of recent enrollees are coming in with health conditions significantly worse than in the past and because a lag in the State capitation rate they are look at a deficit of 2.7 million dollars out of a total budget of \$200,000,000.00. The program has been running at a deficit for the past three years; this may hurt if there is no State relief available. New business system has been suspended until there are more resources in the future. A Project Manager has been hired to help cut expenses and they have started restructuring by cutting jobs to help balance the budget.

**Health, Dwight Nelson**—2016 Budget was approved, looked a funding options for substance abuse, and how to educate the public in this issue, next meeting will be December 1<sup>st</sup>.

**Veterans Services, Lester Jantzen**—hopes everyone will participate in the Veterans Day programs to honor our Veterans on November 11<sup>th</sup>.

**Executive, John Beinborn**—Executive will meet on November 23<sup>rd</sup> at 9:15 a.m. for a Joint Meeting of the Executive and Highway Committee.

**Highway, Don Splinter**—gave the Grant County road report and Platteville salt shed update. Ordered two new trucks before the cost increase next year.
