Mick Whitaker requests CTH B from Old County B Road to Platte Road within the Town of Harrison be added to the list of approved routes. This is approximately 2 miles. It was motioned by Bob and seconded by Nate to approve this route. Motion carried.

John Gillingham requested a portion of CTH Q from Cedar Rock Road up to CTH G and then following CTH G from CTH Q to Shemak Road. This is approximately 1.75 miles. Dave will contact John and put this on the agenda for the next meeting.

Cty U from Dogtail Road and Lovers Lane up to Dutch Hollow Road was requested to be added to the list of approved routes. This is approximately 1.1 miles. It was motioned by Tony and seconded by Jeff to approve this route. Motion carried.
