ADMINISTRATION

State Budget impact on Social Services

DHS.

\$183.2 million increase to fund Medicaid services. \$39.6 million to take children off the Children's Long Term Support waitlist. The amount is estimated to be enough to take all CLTS clients off the list, throughout the state. There is also funding to create a Children's Crisis Treatment Facility. The budget also maintains Consortia contracts at CY17 levels through CY19. Fraud prevention and investigation allocation is being increased by \$500,000 throughout the state. Providers will also be allowed to retain larger contract surplus amounts each contract year and accumulate larger surplus balances over multiple years. The current audit threshold for contractors is \$25,000. The 2018 threshold will be \$100,000.

DCF:

Additional monies will be allocated to all counties, which equal's \$58,000 for Grant Co. DSS Foster Care and Kinship Care will also have increased funding in 2018. There will be no change to the Juvenile Justice allocation.
