Motion by Robert Keeney, seconded by Donald Splinter, to approve the agenda as posted. Motion carried on a voice vote with one opposed.

- 1) IT has been working with our fiber optic provider to get quotes and a project defined
- 2) IT has started the enrollment with diggers hotline
- 3) IT has been diagnosing an issue with Orchard Manor’s Outlook. Outlook from time to time gets disconnected.
- 4) Internet for the UW/Fair Grounds is now being provided from CSB. A new Wi-Fi link is needed to link the Eckstein building for internet access.

- 1) IT has started the process of deploying services

  - d. Documentation of lines
  - e. printers
- 2) general time line points are

  - c. On 4/15/2019 IT helped setup the watch guard system

  - e. On 4/23/2019 CCCP and TDS were able to get SIP phone service up and running
  - f. On 4/29/2019 IT and RACOM reviewed the radio room (1305) for additional equipment.
  - g. On 4/30/2019 IT installed new lines for NCIC communications
  - h. On 5/01/2019 IT started the install of Wi-Fi in the jail pod
  - i. On 5/09/2019 lifeline has completed A/V work for the training room and conference room.
  - j. On 5/13-14/2019 IT and user training for the phone system
  - k. Starting with new 911 central square. More to come as project starts

Mark Stead, seconded by Robert Keeney, moved to approve Orchard Manor Request to pay a former retired employee at their rate of pay at time of their retirement of \$14.57 for LTE work instead of the start rate of Activity Aide pay of \$13.05. Motion carried without negative vote.

Carol Beals, seconded by Mike Lieurance, moved to approve the Personnel Director's report. Motion carried without negative vote.

Gary Ranum, seconded by Carol Beals, moved to go into closed session per state statute 19.85(1)(c) considering employment, promotion, compensation or performance evaluation data of any public employee over which the governmental body has jurisdiction or exercises responsibility as it relates to the Grant County Health Officer. Roll call vote resulted in a carried motion with one negative vote.

Mark Stead, seconded by Gary Ranum, moved to return to open session. Motion carried without negative vote.

Carol Beals, seconded by Mike Lieurance, moved to adjourn to a special meeting May 21, 2019, at 8:00 a.m. and the regular meeting on June 11, 2019, at 8:30 a.m. Motion carried without negative vote.
