#### **Closed Session**

carried.

budgeted amount.

Janney opened nominations for Secretary. Jantzen nominated Bell. No other nominations were cast.

Blume/VanDeWiel: Motion to close nominations and cast a unanimous ballot for Bell as Secretary.
