Advocacy Reports or Activities:

- ADRC Regional Board Meeting Report Reid stated that no action was taken at the last meeting. Elections were held and there was discussion on the second quarter region calls.
- Drive Through Elderfest October 22, 2021 Elderfest will be from 10 a.m. to noon at the Grant County Fairgrounds again this year. The Health Department is offering Covid, flu, pneumonia, and tetanus shots. ADRC will be providing apple cider donuts from Vesperman Farm and resources bags with information and giveaways from other vendors as well as some door prizes.
- Public Hearing for Aging Plan tentatively October 15, Lancaster & Boscobel Reid stated this will be a public hearing for the Aging Plan and Transportation (85.21). More information will be sent when the date(s) are finalized.

Reid reiterated that the budget does not include the Dickeyville meal site or any additional sites.
