- 1. STH 61 in the Town of Boscobel and the Town of Marion, from the intersection with Old 61 to the intersection with Wisconsin Ave including the bridge over Crooked Creek in the town of Boscobel a distance of .3 of a mile.
- 2. STH 61 in the Town of Marion, from the intersection with Old 61 to the intersection with Peer Rd including the bridge over Crooked Creek in the town of Marion a distance of .2 of a mile.
- 3. STH 61 in the City of Fennimore the Town of Fennimore, from the intersection with 2<sup>nd</sup> Street to the intersection with Ideal Rd including a culvert over Fennimore Fork in the town of Fennimore a distance of .4 of a mile.

- 4. STH 133 in the Town of Glen Haven from County V to County V including the bridge over Rattlesnake Creek a distance of .3 of a mile.
- 5. STH 133 in the Town of Cassville from Cassville city limits to Cadwell Rd including crossing over Mill Branch for the distance of .9 of a mile.
- 6. STH 133 in the Town of Cassville from County Rd Y to Far Nuf Road including crossing over McCarthy Branch for a distance of .9 of a mile.
- 7. STH 80 in the Town of Lima from County Road A to Cushman Rd including crossing a box culvert over a tributary to the Little Platte River for a distance of .2 of a mile.
- 8. STH 61 in the Town of South Lancaster from south city limits of Lancaster to Stage Road including crossing over Pigeon Creek for a distance of .1 of a mile.
- 9. STH 133 in the Town of Woodman from County C to County K including the bridge over Big Green River for a distance of 1 mile.

- 16. STH 133 in the Town of Potosi Brewery Hollow to East River Lane for a distance of .7 of a mile.
- 17. STH 61 in the Town of Potosi North Main / Stage Road to Shaeffer Drive for a distance of 1.2 miles.
- 18. STH 81 in the Town of Cassville Garden Prairie to Rattlesnake for a distance of .2 of a mile.
- 19. STH 35 in the Town of Bloomington County A to the village limits of Bloomington for a distance of .1 of a mile.
- 20. STH 133 in the Town of Watterstown Old C to village limits of Blue River for a distance of .3 of a mile.
- 21. STH 133 in the Town of Waterloo County N to County N for a distance of .5 miles.
