Alesha expressed to the Board how appreciative we are of the wage increase. She explained the shortage Orchard Manor still encounters with the nursing staff. Britney shared that our PRN staff is required to give 16 weekend hours each month.

Roger Guthrie made the motion seconded by Donald Splinter to approve the extension of the \$5.00 weekend differential for nursing staff to be reviewed again in March 2024. Motion carried, voice vote.

Garry shared with the board that Orchard Manor had 3 unit ventilators blow coils. Garry is currently unable to find coils. He is getting pricing on replacing. The door controls at Orchard Manor have been postponed until the end of the year. On December 6th there was a power outage that last about 3 hours. The generator worked as planned. Garry received a phone call from Dr. Robert Stader, who recommends installing humidifiers into the facility.

Alesha Erdenberger and the Committee discussed the following Orchard Manor items:

- The current census is 48 geriatric and 24 intellectually disabled residents.
- We are now recruiting for CNA's, Nurses & Activity Aide.
- Alesha is still finishing up the 2024 budget with Amanda.
- 10 new employees hired in November.
