HIGHWAY COMMITTEE MEETING March 10, 2022

The Highway Committee of the Grant County Board of Supervisors met on Thursday, March 10, 2022 at 9:00 A.M. in the County Board Room of the Administration Building in Lancaster, Wisconsin and via Zoom.

Notice of the meeting was sent to the media and the agenda was posted at the Administration Building and Highway Office.

Motion by John Patcle, seconded by Lester Jantzen, to approve the agenda as printed. Motion carried.

Motion by Mark Stead, seconded by Dwight Nelson, to approve the minutes of the February 10, 2022 and February 23, 2022 meetings as printed. Motion carried.

Motion by Dwight Nelson, seconded by Lester Jantzen, to accept the February Highway Accounts Payable Report as reviewed by the Committee. Motion carried.

For the month of January, Grant County spent \$267,302.48 maintaining the State Highway System in the County. We are currently under the estimated RMA budget by \$2368.19.

County crews have been out on 17 snow events thru February, using 2724 ton of salt maintaining the County Highway System. At \$75.87 per ton, a total of \$206,669.88 has been spent thus far on road salt.

State crews have used 4987 ton of salt thus far thru February. They have also been busy cutting brush at various locations and repairing damaged guardrail.

State Highway usage request for ATV routes in Grant County WI

Under Wis. Stat ss. 23.33.(4)(d)3.b and 23.33 (11)(am)3., the County authorizes the operation of ATVs/UTVs on:

- 1. STH 61 in the Town of Boscobel and the Town of Marion, from the intersection with Old 61 to the intersection with Wisconsin Ave including the bridge over Crooked Creek in the town of Boscobel a distance of .3 of a mile.
- 2. STH 61 in the Town of Marion, from the intersection with Old 61 to the intersection with Peer Rd including the bridge over Crooked Creek in the town of Marion a distance of .2 of a mile.
- 3. STH 61 in the City of Fennimore the Town of Fennimore, from the intersection with 2nd Street to the intersection with Ideal Rd including a culvert over Fennimore Fork in the town of Fennimore a distance of .4 of a mile.
- 4. STH 18 in the Town of Wyalusing County C to Upper Bridgeport in Crawford County including the bridges over Wisconsin River for a distance of 1.1 miles.
