2025 TAD Grant Application

Kristin Schier reviewed and discussed the 2025 TAD Grant application. She explained that the pre-application has been submitted; it was due July 15; and this cycle will be year four of the five-year grant cycle. She stated that she anticipates no significant changes with the application. Kristin asked the Council for approval and support for the 2025 grant application.

Motion by Nate Dreckman, seconded by Craig Reukauf, to support the continued design and implementation of the Grant County Treatment Courts and to move forward with the TAD grant application for 2025. Motion carried without negative vote.

Family Advocates Appointment to the CJCC

Debra Reukauf noted that Family Advocates asked to be a member of the CJCC at the last meeting. It was noted that no one from Family Advocates was present. The council discussed membership and the Bylaws.

Opioid Settlement Update

Robert Keeney provided an update to the council. There is another round of opportunities/grants opening up in September. He noted that there is a budgeted amount of \$40,000 for this year, and the hope is to increase the budget for next year.
