### **2025 TAD Grant Application**

Kristin Schier informed the council that the 2025 TAD grant application opened September 16, and the application is due October 21. She informed the council that there is also an application webinar scheduled for today, and she plans to attend.

### **Opioid Settlement Update**

Robert Keeney gave an update on the opioid settlement funds – there were no applications for period ending August 20. He noted the next application deadline is November 19, and there is approximately \$40,000 available this year.

Kristin Schier informed the council that she intends to file an application for the Treatment Court Teams to attend the All Rise National Treatment Court Conference in May. She stated there is currently 8 – 10 team members that would like to attend, including Judge Riniker. She noted that she intends to have the application filed for the November 19 deadline.

### **Strategic Plan**

Deb Reukauf shared the next meeting dates: October 4 and October 18 from 10:00 a.m. to noon. The October 4 session will be held at City Hall in the Senior Center. The October 18 session will be held at Schreiner Memorial Library. She noted the first session was very well attended.
