### REPORTS & COMMISSION BUSINESS

8. **Amtrak Presentation – Arun Rao, AICP, Amtrak.**

Rao, Network Development Specialist with Amtrak, formerly worked for WisDOT, presented information on current Amtrak passenger train operations as well as possible future projects. Currently, there are 16 trains operating in WI daily: includes 3 routes, 8 stations, and had approximately 724,800 riders in 2023. There are currently less than 750 miles of track supported by the state. The Borealis section has far exceeded expectations, and celebrated 100,000 riders in the 1<sup>st</sup> 5 months of operation. There are many new platforms for projects right now: Columbus will be getting 2 new platforms, Tomah has one under construction, and Portage was recently completed. Grants: the Muskego Yard bypass in Milwaukee was recently announced, new corridor development funded by the FRA which includes planning funding at 100%, service development and engineering funding at 90%, and then opens up opportunities for additional funding including operational financial support for 1<sup>st</sup> 6 years of operations.

9. **WRRTC Financial Report – Huttenburg, Treasurer**

**10. Wisconsin & Southern Railroad's Report on Operations – Lucht, WSOR**

Lucht provided operational updates: Reedsburg sub tie project is currently active, with crews working on final surfacing between Waunakee and Devils Lake, in hopes of being complete before snow, once the couple of sections in Waunakee that need repair are complete, WSOR will be increasing speeds from 10 to 25 mph; Town of Westport just North of Madison, WSOR is working on rebuilding County Hwy M either yet this year or next Spring; Village of Arena is done with a nearby bike path that uses the same crossing; and the brush cutter is in and will continue being used through the winter around the network. Other updates included: Private crossing agreements are in process and WSOR is currently working the Genesee Realty in Waukesha County, who has been easy to work with, and Bernard Gilbert in Palmyra is the next one on the list. WSOR recently worked with Darien to permanently close 3<sup>rd</sup> Street for a Farm City expansion project where double track is used to get to the main line in Elkhorn. The grain market has impacted movement.

**11. WisDOT Report – Mohlke - WisDOT.**

Mohlke reported: Merrimac Bridge – working on Pier 15 and 16 right now, completion will not happen until early Spring next year, and the weight restriction will not be officially open until it is complete and the testing has been done; Janesville Bridge project working on preliminary engineering and environmental assessment; and the annual Freight Rail Conference on Tuesday of next week.

**12. Committee Updates / Recommendations**

Huttenburg & Bolitho provided a status update on the track removal project: Treno, LLC was in WI and were removing rail from the site last week, some of which will be trucked, and some sold locally; various sections of rail that contained historical information, i.e., rolling date, weight, etc., will become part of a historical information section along the trail and is currently at Dane County; contractor is hopeful that project will be complete in 2 weeks, and Chris James, Dane County Park Planning Manager, is satisfied with work being done; monitoring of the site is necessary, as people are using it to drive on; however, once WRRTC portion of the project is complete, WisDOT will be responsible for securing the corridor. Krueger reported that the two projects are out for bid, 10 firms showed up for mandatory pre-bid meeting held at the end of last month, bid opening on November 19<sup>th</sup>, and contract will be awarded by Village of Sauk City Board on November 26<sup>th</sup>.

**13. Aurora Street Crossing, Middleton, WI – Krueger, Chair**

Potter briefed the commission on the status of the Middleton crossing and public versus private. OCR determined it was private, and the court of appeals overturned the decision and determined the crossing was public, now it will be up to the OCR to appeal that decision.

**14. Registration Fees for Conferences – Chair / Admin**

Potter: Private Crossing Agreements – working with WSOR and WisDOT to update the form that are required through our agreements, and what is here today is the revised agreement with all parties in agreement with the revised form. Right of entry agreement is between WSOR and contractor.
