Amend CJCC Bylaws

Kristin Schier explained the changes she made to the CJCC bylaws: Jail Medical Director, or designee, will be added as a permanent representative of the CJCC; a representative of the healthcare community will be removed as a citizen representative. She opened this up for discussion. Craig Reukauf agreed with the changes, as this was what was agreed upon at the last meeting.

Judge Craig Day made a motion to approve and adopt the amendments to the CJCC bylaws. Craig Reukauf seconded the motion. Motion carried without negative vote.

Public Health Vending Machine Program
