2024 Procedural Fairness Surveys

Opioid Settlement Update

Robert Keeney reported that the task force committee met last week and reviewed one application from Unified Community Services. The application was approved for \$70,000. Currently, there is one application for review in August.

Strategic Plan / Storyboarding Presentation

Kristin Schier reviewed the final Summary Report, along with the Individual Group Action worksheets. Kristin opened up the discussion.

Gary Ranum noted that one task that repeatedly appeared is the need to talk to one another, and that he believes that the council under-utilizes the open discussion portion of the CJCC meetings.

Sheriff Reukauf noted that he'd like to see the agencies set-up meetings and follow up at the next CJCC meeting.

Holly Knapp brought up for discussion having each department present what that department is responsible for, what services they offer, a few things the department would like to solve, etc. The council discussed. It was determined that the Sheriff and Public Defender would present at the next CJCC meeting. Holly offered to make a template for the presentation.

Mike Foley expressed his appreciation for Teen Court, and he hopes to get more students involved.

Jeff Erickson asked Kristin Schier about the AllRise25 Conference she attended last week. Kristin shared her experience and thoughts and noted that she would share the material with him.
