Vern Lewison, seconded by Vince Loeffelholz, moved to approve the agenda. Motion carried.

Hans Kostrau, seconded by Dwight Nelson, moved to approve the minutes with the corrections. Motion carried.

Communications – There were no communications.

Appointments – Chairman Patcle recommended the appointments of Hans Kostrau and Dale Hood to the ADRC committee. John Patcle, seconded by Lynn Moris, moved to approve the recommendations. Motion carried.

Employee Recognitions – Chairman Patcle presented a plaque to Mercille Roesch for her 32 years of service to Orchard Manor. Chairman Patcle presented a plaque to Judy Call for her 33 years of service to Orchard Manor.

Marge Sherwin came before the board representing the Tourism Council. They are doing a 4th grade essay contest "Hidden Treasures of Grant County" and also a Photo Contest of "Hidden Treasures in Grant County". The Dairy Breakfast will be held in Fennimore this year.

Family Care Update – Andy Phillips and John Reinemann, from Wisconsin Counties Association, were present to discuss the Family Care Program. A Long Term Care district would provide the services which would treat everyone like an HMO. A board member would be appointed to the Long Term Care district. Our region would consist of 8 counties. Neal Blackburn and Fred Naatz also participated in the discussion. A resolution will be brought before the full county board in June. A private provider could take over if the county does nothing. Members will be serviced by someone. A private provider would be cheaper because of not paying the benefits the county pays but the county's commitment brings quality of care to the public. The 8 county Coalition has received a letter of intent from the state to contract with the Southwest Wisconsin Care Management Coalition to provide the Family Care benefit, contingent upon successful completion of the certification process. A request for a 5-member committee to meet and discuss the Family Care issue was presented with Chairman Patcle making the appointments at the next meeting.

2007 Departmental Report – Lynn Moris, seconded by Linda Adrian, moved to approve the 2007 Departmental Report. Motion carried.

Orchard Manor Land Sale – Tony Runde informed the board of the request by Larry's Welding to purchase 2 acres, from the county farm, to expand his operation at approximately \$8,000 to \$10,000/acre. The Orchard Manor committee approved the sale at \$11,000/acre. Hans Kostrau, seconded by Pat Schroeder, moved to accept the purchase offer at \$11,000/acre. Motion carried.

Transfer of Funds – The Finance Committee approved the request from the Health Department to transfer \$4,198.21 from the general fund to the Health Department for an LTE employee's retirement benefits. Pat Schroeder, seconded by Bill Biefer, moved to approve the request. Motion carried.
