Replica tractor sales were discussed.

The noise concern with the sale ring in the Livestock Pavilion was discussed.

The committee watched an on-line demonstration on fair management software.

Motion by Kyle Vesperman, seconded by Lynn Moris, to approve and send the livestock claim from Lancaster Veterinary Clinic on to the full County Board excluding payment for a cat. The balance to pay is \$1458.75, which excludes the cat (\$1,539.25-\$80.50). The livestock claim from Platteville Veterinary Clinic in the amount of \$130.05 was also approved to be sent on. Motion carried.

The committee took a five minute recess.

Motion by Vince Loeffelholz, seconded by Bob Keeney, to move to closed session. Roll call vote was taken and passed unanimously. Motion carried.
