The state is requiring a public hearing for 85.21 Grant to be held within 30 days for submitting the grant.
- e. Concern noted over the reduction in COP Meals She stated DSS has omitted meals from several clients in Platteville and Cuba City. Gayle will discuss contract concerns with Fred Naatz before the next meeting.
- f. Federal Mileage Rate changes from .55 cents/mile to .50 cents/mile
- g. Regional Board Updates: The next board meeting is Thursday, November 19<sup>th</sup>. The board will review the Function Screen Policy and the Grievance and Appeals Policy
