Economic Development is asking the County Board's approval for \$1,500,000 in CDBG-ED funds to be loaned to the Wausaukee Composites. The funds will be utilized by Wausaukee Composites to purchase manufacturing equipment and expand operations in Cuba City and retain 3 existing full-time jobs and create up to 200 new jobs. Proposed activities must benefit low and moderate income individuals through the creation and/or retention of jobs. The company will manufacture the cone structure on the face of the turban windmills; construction is targeted to start in 2011.

<u>Admissions Policy</u>: The committee reviewed the Admission Policy for the Grant process. All in agreement that the language is correct and reflects what the committee is looking for in rating the grant applications.
